Order Acceptance:

Prices:

Terms:

Net 30 days. 1 ½% per month will be assessed on past due invoices.

Freight:

Normal transportation cost will be prepaid and added to customer's invoice.

Claims:

Claims for shortages, breakage or damage must be directed to the carrier within (5) days after receipt of shipment, as our responsibility for quantity and condition of shipment ends with the acceptance by the carrier.

Returns:

No merchandise may be returned without prior written authorization. This authorization will be issued at EVERGREEN LIGHTINGS discretion and must be requested by the customer within 60 days of the original shipment date.

Cancellations:

Cancellations of orders will be accepted only if made in writing and received prior to production of order. Verbal order cancellation will not be accepted. Orders in production will be subject to re-stocking fee.
